4. **OBJECTIVES OF THE TRUST:** The aims and objects of the Trust shall be in the nature of Charitable within the meaning of Sec. 2 (15) of Income Tax Act, 1961 which are broadly stated as hereunder :
 - a) Relief and help to the poor in distress, by contributing either in cash or kind directly or through other charitable organizations which are recognized under section 80 G of the Income Tax Act. 1961.
 - b) Medical relief to the sick and suffering, physically / mentally handicapped persons by contributing funds or by running free Hospitals and Clinics free of cost.
 - c) Help the poor and deserving students for carrying on with their education by way of giving free Scholarships, Loan Scholarships and provide free hostel facilities.



5. **VESTING OF PROPERTIES:** The properties and Assets of the Trust shall vest in the Trustees and their successors in office perpetually and irrevocably,
6. **INVESTMENTS:** The Funds of the Trust shall be invested in acquiring both Immovable properties to increase the income of the Trust and those securities which are in accordance with the provisions of the Section 13 (1) (d) of Income Tax act, 1961.
7. **NUMBER OF TRUSTEES:** The number of Trustees shall not be less than 5 (Five) and not more than 15 (Fifteen) and the Authors of the Trust, who are the Founder Trustees for the time being shall have the power to increase the number of Trustee way of nomination on the basis of "the majority decision, taken in any of the Trust Meetings, subject to the maximum mentioned above.
8. **MANAGEMENT:** The president who shall be in charge of the administration of the Trust and Secretary who shall render proper accounts and do all such acts. Deeds and things that are generally done by the Managing Trustee in the overall interest of the Trust. The tenure of the Office of Managing Trustee shall be for Three Years at a time.
9. **DURATION:** All the Authors of the trust who are the Trustees for the time being have formed themselves into Board of Trustees shall be for 5 years and thereafter they will be eligible to continue in the office for Three years at a time if they are re-nominated as stipulated in para 8 above unless they resign or become incapacitated in any manner.

10. **VACANCY OF THE TRUSTEES:** Any Vacancy of the trustees that may arise due to reason of death, insolvency or resignation of any Trustee shall be filled up by the continuing Trustees by majority decision and such Trustees so appointed shall be for the residuary period.
11. **REMOVAL OF TRUSTEES:** If it is found by the Board of Trustees that they Trustee/ Trustees is found to be working or involved himself working against the objects and interest of the Trust in any manner the Board shall have the power to remove such Trustee or Trustees by a 2/3rd majority of the members present in the meeting called for the said purpose and the decision of the Trustees shall be final.
12. **CASTING VOTE:** The President to presides over the meeting of Trust shall have a casting vote in addition to his vote, if there is a tie in the voting on any matter or issue on which a decision has to be taken.
13. **POWERS OF THE TRUSTEES**
 - a) The trustees shall have power to acquire, possess, own hold and enjoy all properties, Movable and immovable on behalf of the Trust, and to borrow, sell, dispose off, alienate, encumber, lease all such properties for and on behalf of the Trust and to derive income there from and to invest capital and income, as they may consider best, subject to the provisions of any law for the time being in force relating to charitable Trusts.

property and to insure the same against loss of damage by fire and defray the costs and expenses incurred by them in so doing out of the income or capital of the Trust property at the discretion of the Trustees.

- c) The Trustees shall have power to frame such subsidiary rules of business and shall have power to alter, add or amend the same from time to time as may be necessary for the conduct of their business not inconsistent with the provisions of section 2 (15), 10, 11, 12, 13 and 80G of the Income Tax Act, 1961 with prior approval from the commissioner of Income Tax.
- d) The Trustees shall have power to open a Bank Account in the name of the Trust with any Scheduled Bank or Banks and the Managing Trustee shall have the power to operate such Bank Account/s jointly with Secretary or any one of the party of 1st to 5th party.
- e) The Trustees shall have power to maintain and defend all suits in any Court of Law in order to preserve and protect the property of the Trust.
- f) The Trustees shall maintain regular Books of Accounts of the Trust, which shall be duly Audited every year by a Chartered accountants who is appointed by the Trustees and the Accounting year shall be the financial year.
- g) The Trustees shall meet from time to time at least once in there months for the purpose of efficient Management of the Trust, to take collective decisions in proper carrying out of the objects of the Trust and all the decisions shall be taken by way of majority of the Trustees who are present at such Meeting.

15. **PROCEEDINGS OF THE MEETING:** The Managing Trustee shall preside over all the Meeting of the Trustees. In the absence of the Managing Trustee, any Trustee may preside and conduct the proceedings at the request of all the Trustees present. All the proceedings of the Meeting shall be property minted in the Minutes book which shall be signed by the presiding Trustee. The Secretary or Joint Secretary shall call for the meeting of the Trust in consultation with the Managing Trustee and fix the dates by giving and advance notice of about 7 days or shorter notice in the case of emergency.
16. **APPLICATION OF INDIAN TRUST ACT:** All the clauses which are not specifically enumerated in this Trust Deed shall be governed by the respective Clauses of the Indian Trust Act, 1882.
17. **DELEGATION OF POWERS:** The Trustees shall be empowered to delegate the powers to any professional Bodies, Committees or any other person/ persons, and take advise as and when necessary for carrying out of the objects of the Trust in a more effective manner.
